It's cruise planning time. For those of you who expect to be in the New England area this summer, we once again have two rendezvous scheduled.

Monday, July 16th: Tenants Harbor, Maine. Art Hall has organized dinner at the East Wind Inn, to be preceded by cocktails aboard. East Wind really is an inn, with overnight facilities and breakfast served. Their dinghy float is just to the east of Cod End's float and gas dock. They have a few moorings for rent. Cod End (Ch. 16) controls the bulk of the moorings in the harbor, but don't try to get in to their float and gas dock at low tide. The mud is soft and very sticky.

Thursday, August 9th: Dering Harbor, Shelter Island, New York. You are invited to join me for dinner at the Shelter Island Yacht Club, preceded by cocktails aboard *MANATUCK*. Call the Yacht Club on Ch. 71 for a guest mooring or anchor off to the east or south of the mooring grid.

I'm also pleased to announce that the ASOA is now the owner of a batch of Seabreeze pennants. A repeat of the existing design, they are 12" x 18" white swallow tails with a red "A" in a circle and red border. The price is \$26.50, first come, first served, with about half currently held for those who indicated interest at the St. Michaels meeting.

The enclosed roster revision sheet shows the addition of hull # 5, our 119th boat. That's 88% of all those built. That's great. Keep up the search.
